DSSSB vide Result Notice No. 1417 dated 27/09/2022 provisionally nominated **27 candidates (UR-08, EWS-02, OBC-07, SC-04, ST-02, OH-01, VH-01 & ExSM-02)** and also provisionally nominated **09 waitlist candidates (URWL-02, EWSWL-01, OBCWL-01, SCWL-01, STWL-01, OHWL-01, VHWL-01, Ex.SMWL-01)**, as per their merit for the Post of ASSISTANT GRADE-II under Post Code-22/21 In DELHI STATE INDUSTRIAL & INFRASTRUCTURE DEVELOPMENT CORPORATION LTD (DSIIDC), subject to fulfilling all conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms and e-dossiers. **As per the Board's resolution dated 14/07/2022, the Board has not undertaken scrutiny of documents uploaded in the e-dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code.**
2. The User Department i.e. DSIIDC vide letter dated 21/09/2023 has provided complete status report on utilization of the main list and the waiting panel of post code 22/21 along with the cancelled **24 dossiers (UR-07, OBC-06, SC-04, ST-02, EWS-01 ExSM-02, OH-01, VH-01) from main panel and 05 dossiers (OBCWL-01, STWL-01, EWSWL-01, OHWL-01, VHWL-01) from waiting panel.** . The User Department has requested to provide additional candidates from the reserve panel of post code 22/21.
3. The validity of the reserve panel of post code 22/21 is valid up to 26/09/2023 and the returned dossiers along with complete status report are received in DSSSB prior to expiry of waitlist panel, hence, as per Board's resolution dated 19th May, 2021, in suppression of earlier policy dated 13 June 2019 and in accordance with Services Department Circular No. F.16(3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, out of the waiting/reserve panel comprising all the candidates above minimum qualifying marks in Tier-I (G) Examination, the candidates having following roll numbers (Tier I) are hereby provisionally nominated for the post of ASSISTANT GRADE-II under Post Code-22/21 in DSIIDC, Govt. of NCT of Delhi, subject to fulfilling all conditions of eligibility and also correctness of the information furnished by the candidates in their online application forms and e-dossiers:

4. The provisional nomination of above **21 candidates from reserve panel of post code 22/21 (UR-07, OBC-06, SC-02, ST-02, EWS-01, ExSM-01, OH-01 & VH-01)** is made in order of merit with a request to the User Department to utilize the same, in conformity with DoP&T guidelines and instructions of Govt. of NCT, Delhi issued from time to time and also mentioned in the main Result Notice No. 1417 dated 27/09/2022. The nomination of the above candidates shall be further subject to thorough verification of candidature of the candidate by the User Department including the identity of the candidate.
5. The provisionally nomination of above **21 candidates from reserve panel of post code 22/21 (UR-07, OBC-06, SC-02, ST-02, EWS-01, ExSM-01, OH-01 & VH-01)** has been

processed purely on the basis of marks obtained by the candidates in the examination held on 26/02/2022 & 27/02/2022 and also claims made by the candidates in their online application forms of the post code 22/21 for the post of ASSISTANT GRADE-II under Post Code-22/21 in DSIIDC, Govt. of NCT of Delhi. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, **the Board has not undertaken scrutiny of documents uploaded in the e-dossiers and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage.** The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 01/21 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 22/21 as on cutoff date 14/04/2021 before issuance of offer of appointment to the post.

6. The User Department, being Cadre Controlling/Appointing Authority, shall strictly follow the merit based ranking of the candidate.
7. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
8. While operating the waiting panel/reserve panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
9. The user department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal *Ab initio*.
10. As soon as validity period of the waiting panel expires and /or number of notified vacancies are filled up hence waiting panel becomes redundant, the user depart shall return the cancelled and unutilized dossiers to DSSSB with complete details/ statistics forthwith.
11. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
12. Wherever the Court has directed to not declare result without leave of the court such cases will be dealt separately, if falling in main result/proposed 20% waiting panel list. The user department shall decide such cases subject to outcome of court case(s).
13. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
